## 1. Scanning the QR code and using the service

- 1.1. When scanning the QR code and starting to use the service, the Data controller of **Ltd "CIRET"** (hereinafter the **Data controller**), registration No. 1085032009292, legal address: 180000, Russia, Pskov, 1, Lva Tolstogo str., 4<sup>th</sup> floor, starts processing personal data because the website contains cookies created by the Google Analytics program Google Inc.

If you do not want the Data controller to get information about your activity on the website, you need to activate the Google Analytics Opt-out Browser Add-on (<a href="https://support.google.com/analytics/answer/181881">https://support.google.com/analytics/answer/181881</a>). This add-on communicates with the Google Analytics JavaScript (ga.js) to indicate that data for the respective website visit should not be sent to Google Analytics.

## 1.3.1. How to turn off cookies?

For business process analysis and customer behavior research, it is not planned that the data obtained will be deleted from the Data controller's Google Analytics account (the communication made on the website <a href="https://www.mobile-consultant.net/">https://www.mobile-consultant.net/</a> is not stored), but you can control and delete cookies at any time. You can delete all cookies that are on your computer and most browsers can be set up to block cookies on your computer.
